

Sure Cross Configuration Software

The following software configuration tools are used for different products and may require different cables.

User Configuration Tools (UCT)

Sure Cross User Configuration Tool (32-bit or 64-bit versions)—This is the older version of the Performance series configuration software. Eventually it will be replaced by the 2nd Gen version. Both will work, but the revised version has more features. Sure Cross User Configuration Tool (2nd Gen)—Newer version of Sure Cross User Configuration Tool. Use this version when possible.

Cables Required:

- USB to RS-485 adapter cable model BWA-UCT-900 for 1 Watt radios
- USB to RS-485 adapter cable model BWA-HW-006 for all other radios
